# **BRIEF PROGRESS REPORT ON APAARI ACTIVITIES**

(January - June, 2015)

The Asia-Pacific Association of Agricultural Research Institutions (APAARI) is an apolitical, neutral, non-profit forum of National Agricultural Research Systems (NARS) in the Asia-Pacific region and was established in 1990 at the initiative of Food and Agriculture Organization of the United Nations (FAO). It has its headquarters at the FAO Regional Office for Asia and the Pacific in Bangkok. The main mission of APAARI is to promote the development of national agricultural research systems in the Asia-Pacific region through facilitation of intra-regional, inter-institutional, and international cooperation/partnership. APAARI has been active in fostering the overall agricultural development by addressing the concerns of hunger, poverty, environmental degradation and sustainability of agricultural production. It has completed 25 years of its establishment with an impressive record of achievements.

APAARI organized/co-organized several activities comprising meetings/consultations/conferences/ workshops/training programs during January - June, 2015. These included: i) APAARI Executive Committee Meeting, ii) Tropical Agriculture Platform - CD (AIS) Expert Group Workshop, iii) International Training Course on Smart Use of Fertilizers to Improve Crop Production and Soil Conservation, and iv) CRP Dryland Cereals Scholarship Program. Also, a number of publications, including proceedings of conferences/workshops held were brought out and widely disseminated to APAARI members and other stakeholders.

A brief account of the accomplishments during the period under report is presented here for kind information of APAARI members/partners.

## I. Meetings and Expert Consultations

#### 1. APAARI Executive Committee Meeting

The first meeting of the new APAARI Executive Committee (EC) was held at the Rama Gardens Hotel, Bangkok, Thailand on 12 May, 2015 under the Chairmanship of Dr Suwit Chaikiattiyos, Deputy Director General, Department of Agriculture (DOA), Thailand who officiated in place of Mr Anan Suwannarat, Chairman, APAARI and Director General, DOA, Thailand. The meeting was attended by 24 participants including APAARI members and special invitees. At the outset, the participants expressed special concern on the tremendous loss to life and property in Nepal, a member country of APAARI, due to an earthquake on 26 April, 2015. On the Chair's request the participants observed a one minute silence in memory of the people who lost their lives. It was also decided to include a special agenda item to deliberate on exploring with Nepal authorities how APAARI could contribute to the recovery and rehabilitation of agriculture in Nepal. The following are the highlights of the decisions and outcomes of the meeting:

- APAARI Progress Report November 2014- April 2015 was endorsed and its relevant aspects would be included in the Progress Report: January July 2015.
- Audit Report and Audited Financial Statements as audited by APAARI External Auditor for financial year 2014 was endorsed.

- The GAAP Professional Audit Co. Ltd. was approved as External Auditor for APAARI for the biennium 2015-16.
- The Executive Committee approved APAARI Work Plan 2015 for implementation. The major activities included are : i) Revisiting APAARI Vision 2025, ii) High Level Policy Dialogue on Investment in AR4D in Asia-Pacific Region, iii) M&E towards Outcome and Impact Assessment, iv) Policy Dialogue on Transforming Towards Knowledge Based Agriculture in Southeast Asia, v) Dialogue on Performance of Bt. Brinjal in Bangladesh and Prospects of Its Wider Adoption, vi) Development of Communication Strategies for Adoption of Agribiotechnology in Asia-Pacific, and vii) CRP on Dryland Cereals Scholarship Program.
- Major highlights of Revisiting APAARI Vision 2025 are: i) development of vision document containing vision, mission and goal statements with outline of broad system level outcomes, strategic thrusts and strategic interventions. ii) vision document to be developed in close consultation with EC members and other eminent persons who participated in the EC meeting, iii) draft vision document thus developed will go through wider consultation with APAARI members, partners and stakeholders, iv) the Executive Secretary of APAARI is tasked to oversee the development, and v) the second stage of strategic planning on mid-term program implementation plan will be undertaken after the acceptance of the revised vision document.
- APAARI Income-Expenditure Plan for 2015-16 was approved for implementation. The highlights are: i) estimated income (US\$ 825,881 and predicted expenditure (US\$ 805,547) during 2015, ii) estimated income (US\$ 724,074) and predicted expenditure (US\$ 795, 838), with a provision of using US\$ 71,764 from the reserve funds during 2016.
- The Asia-Pacific Seed Association (APSA) has been nominated and endorsed as a representative of the private sector on the APAARI Executive Committee for the biennium 2015-16.
- Proposal for an additional seat to jointly represent the Association of International Research Centres for Agriculture (AIRCA) and Universities (Higher Education Sector) on the APAARI Executive Committee was approved, subject to the approval of the appropriate amendment to the APAARI Constitution by the APAARI General Assembly.
- The Executive Committee approved the following composition of APCoAB Steering Committee for the Biennium 2015-16.

- It was resolved that APAARI would explore the possibilities of supporting the recovery and assisting in rehabilitation of agriculture that has been adversely affected in Nepal because of the recent earthquakes in the country.
- FAO RAP has established the Asia-Pacific Extension and Outreach Network (APAEON). FAO will be the Chair and APAARI will be the Vice-Chair of the Steering Committee of APAEON.
- The EC took note of the three major decisions made by the CG Fund Council in its meeting held on 27-30, April 2015 in Bogor, Indonesia: i) agreement to submit revised SRF to funders, ii) establishment of CGIAR systems organization, and iii) plan on resource mobilization and innovative financing.

#### 2. Tropical Agriculture Platform - CD (AIS) Expert Group Workshop

APAARI is one of partners of Tropical Agriculture Platform (TAP) and a member of its Global Task Force (GTF). Based on the recommendations of TAP Steering Committee and TAP Global Task Force, an Expert Group was created to develop the Common Framework on Capacity Development (CD) for Agricultural Innovation System (AIS). Dr Bhag Mal, Senior Consultant, APAARI, attended the CD Expert Group Workshop held at Montpellier, France on 19-20, March, 2015. The workshop provided a platform to TAP partners to share their on-going and planned activities and provide inputs on how this can inform and be linked to the Framework.

The discussion was held around three main themes: (i) Elements of the Framework, (ii) Needs Assessment, and (iii) Monitoring and Evaluation. The Framework needs to deliver operational and

practical guidance on CD for AIS at system and project levels and at the same time it should remain adaptable and flexible. The draft of the Framework is likely to be available by 25 June which will be circulated to the wider expert group, Tap Global Task Force and TAP Steering Committee for feedback and endorsement. The validation of the Framework in pilot countries (Bangladesh and Laos in Asia region) is planned to begin in September, 2015 in the context of CD (AIS) Project.

# **3.** International Training Course on Smart Use of Fertilizers to Improve Crop Production and Soil Conservation

The Food and Fertilizer Training Centre (FFTC), Asia-Pacific Association of Agricultural Research Institutions (APAARI), Council of Agriculture (COA), Chinese Taipei, and Taichung District Agricultural Research and Extension Station (TDARES) jointly organized the "International Training Course on Smart Use of Fertilizers to Improve Crop Production and Soil Conservation" at Changhua County, Taichung, Taiwan on 11-15 May, 2015.

This five-day training course aimed to introduce and teach the participants from developing countries in the Asia-Pacific region the concept, theory, and application of judicious use of fertilizers through the smart ways. The training program included keynote presentations, laboratory practices and on-site field studies. Nine participants from 8 countries, namely, Bangladesh, Bhutan, Fiji, India, Nepal, Pakistan, Papua New Guinea, and Thailand nominated by APAARI attended the course.

#### 4. Dryland Cereals Scholarship Program

APAARI has signed an MoU with ICRISAT to be a partner in its CRP Dryland Cereals Scholarship Program for which funding support of USD 150,000 has been provided by ICRISAT. Under this program, full or partial support will be provided to candidates from the countries in South Asia and Central and Western Asia to pursue their Ph.D. and Post-Doctoral research related to dryland cereal crops, namely, barley, finger millet, pearl millet and sorghum. The disciplines of study include Agriculture Economics, Food Science, Nutrition, Molecular Genetics, Plant Breeding, Integrated Crop Management, Crop Physiology, Entomology, and Gender.

The objective of the program is to: i) develop a new cadre of scientists with core competencies, knowledge and experience in advanced science and technologies that address productivity and quality enhancements, post-harvest value and policy interventions for the dryland cereals; ii) encourage and develop excellence in fundamental and practical research capabilities in women and early-career scientists in developing countries to address global challenges in agriculture, with a focus on dryland cereals, and iii) strengthen and enhance human resource capacities of national agricultural research institutions in the developing countries in Asia.

A total of nine applications for Ph.D. Scholarship and two applications for Post-Doctoral Fellowship were received from India, China and Sri Lanka. Based on the criteria: i) contribution to improvement of dryland cereal crops, ii) motivation, iii) integration of project/thesis in the work plan, iv) nominating scientist's reference, and v) specified crops and disciplines, the applications were evaluated by APAARI Expect Committee and based on scoring, seven candidates for Ph. D. Scholarship and one for Post-Doctoral Fellowship were selected and the list was sent to ICRISAT Oversight Committee for their comments and approval.

#### 5. Other Important Meetings

#### Meeting with Director, APSA

Dr Raghunath Ghodake, Executive Secretary, APAARI met with Dr Tom Burns, Director, APSA at APSA Office in Bangkok on 19 January 2015 to introduce himself as a new Executive Secretary of APAARI. In the meeting, Dr Ghodake discussed with Dr Burns about a seat of private sector on the APAARI Executive Committee as per the decision of the APAARI General Assembly in 2014 to push closer collaboration with the private sector. It was proposed at the General Assembly meeting that APSA will take a seat on the APAARI Executive Committee in 2015 initially as an observer. Since each association has reciprocal membership of each other for many years, Dr Ghodake took this opportunity to discuss possible collaboration on issues of relevance to both organizations.

#### Meeting with CoRRB delegation

Mr Namgay Wangchuk, Director General of Council for RNR Research of Bhutan (CoRRB) along with his team visited APAARI Headquarters, Bangkok on 17 February, 2015 to strengthen collaboration and to meet Dr Raghunath Ghodake, the new Executive Secretary, APAARI. Dr Ghodake updated the CoRRB Director General on various activities of APAARI and also briefed about the forthcoming events. Mr Wangchuk appreciated the progress made by APAARI in promoting agricultural research for development (AR4D) in the region. At the end of the meeting, Mr Wangchuk presented a souvenir to Dr Ghodake and wished him a great success in his new assignment.

#### Meeting with CABI Delegation

A delegation from Commonwealth Agricultural Bureaux International (CABI), headed by Dr Dennis Rangi, Executive Director, International Development together with Dr Wai-Hong Loke, Regional Director, South East Asia, Mr. Sharbendu Banerjee, Global Director, Mobile, Dr Ravi Khetarpal, Regional Director for South Asia and Dr Babar E. Bajwa, Regional Director for Central and West Asia visited the APAARI Headquarters, Bangkok on the 21st May 2015 and met Dr Raghunath Ghodake, Executive Secretary, APAARI and Dr Vilasini Pillai, APCoAB Coordinator, APAARI. CABI is an international non-profit organization that improves lives through knowledge sharing and plant services to solve agriculture and environmental related problems, which are very much in line with APAARI's vision and mission.

Dr Ghodake gave a brief overview of the current and planned activities of APAARI, while Dr Rangi and the team expressed great interest and enthusiasm in working closely and partnering with APAARI in common areas of interest as well as playing an active role as an Associate Member of APAARI. CABI in 2015 looks forward to participating in the High Level Policy Dialogue on Investment in AR4D and in the Dialogue on Transforming Towards Knowledge Based Agriculture Development and in turn APAARI will be participating in the CABI organized regional workshop.

# II. Information Dissemination and Publications

#### A. APAARI website

The APAARI website is being regularly updated with APAARI's news and activities, and general events of specific interest on agricultural research and development in Asia-Pacific region. APAARI reports and proceedings have all been uploaded on the website for free access. Other contents and database were also updated regularly. Besides, APAARI's account on Facebook has also been created to widen communication channels and to capture the views of young professionals.

#### B. Web-based and CD Information

#### APAARI Web Space

APAARI Website www.apaari.org provides access to more than 40 success stories and status reports, 46 issues of APPARI Newsletter, and more than 60 reports and proceedings of expert consultations. The website provides links to NARS in Asia and the Pacific region, partners like ACIAR, FAO, CGIAR, GFAR, AARINENA, FARA, CACAARI and directories such as research networks, projects database, ASTI databases, regional research networks, etc. The website is being updated on regular basis with upcoming events, activities completed and latest publications with introduction of discussion forum, RSS feed Web 2.0 and social networking tools for dissemination of agricultural research information efficiently.

To improve effective dissemination of information, APAARI has been implementing a communication strategy in phased manner. The APAARI website domain and dedicated webhosting services have been renewed.

APAARI website (http://www.apaari.org) has more than 300 linkages to various national, regional and international institutions, networks and other relevant organizations.

APAARI website had received more than 1.15 million hits during the last six months. Among the total number of 73,677 persons, more than half were unique visitors indicating that the website also attracted new comers. On an average, the numbers of pages that visitors accessed per visit were seven. APAARI website attracted visitors from many countries mainly from USA, China, Turkey, Brazil, and Thailand. Top ten downloads from the site were publications on Success Stories highlighting the best practices of

agricultural development in many countries from Asia-Pacific region. This reflects usefulness of APAARI's efforts made so far in popularizing the good agricultural practices in various fields of agriculture for their faster adoption elsewhere.

#### Database Platforms

Under the implementation of APAARI Communication Strategy 2010-2015, APAARI launched Contact Database on its website. It helps to search contact details of APAARI Members by sub-region, country, category, area of activity etc., and allows downloading of contact information. NARS and National Information Nodal Points (NINPs) are welcome to register in this platform and add contacts of their constituencies. The design of databases on ARD Experts and ARD Projects was also completed and it was demonstrated in the Eleventh Meeting of APARIS Steering Committee held on 13 October, 2012. Dr Vilasini Pillai from Malaysia joined as APCoAB Coordinator at Bangkok on 30 March, 2015. She has the responsibility of execution of programs/activities related to agricultural biotechnology in the Asia-Pacific region under APCoAB Program of APAARI.
